President Selmon thanked the Board for the Retreat yesterday. President Selmon reported

on highlights in his report.

New employees were announced: Dr. Steve Sanocki Interim Director of Student Success, Christian Gordon and Sam Legg – Student Services Specialists in the Welcome Center.

Sheila Wahamaki Theater Faculty is retiring and Heidi Romero, Director of Student Success, and Elizabeth Arangure – Martinez, Student Success Coach are leaving MCC.

Strategic Initiatives this month will focus on Goal #9: Provide exceptional environments for Effective Teaching and Learning.

Enrollment Challenges: impacted by demographic decline, college-going rates, and market share issues.

Staffing Challenges – demographic decline, higher turnover, change fatigue, and national competition.

President Selmon made some positive comments about MCCA Summer Conference on how good the conference was and shared some key takeaways for him:

Michigan Workforce and Education Training Collaborative (MWTECH) course offerings

Opportunity to join the new MCCA Emergency Preparedness Affinity Group

Transfr – a hands on simulation-based training to create new career pathways to career success. We will be following up with the vendor coming soon.

- B. Student Success Report -
 - I. Enrollment

Dr. D'Avignon reported on the Fall 2023 enrollment. Yesterday we dropped 320 students for non-payment. We are 87% to our goal, with 3,142 students enrolled. Counseling and Advising has walk/drop-in open from August 14 to August 31. Other strategies were shared that addressed payment issues, advising and recruitment issues.

Trustee Frye reported on the MCCA summer conference. The conference stressed that community colleges are "the community's college." The speakers were great, and Trustee Frye and Trustee Crandall highly recommend attending a MCCA conference. The next MCCA conference is July 31 – August 2, 2024, at Mission Point on Mackinac Island.

B. Foundation Update

Six annual fund drives are in place for this fiscal year: employee giving drive, end of year campaign, monthly giving campaign, alumni giving appeal, spring into giving (support the Jayhawks \$24 for 24 graduates), and an MCC-specific giving day in June. Annual fund campaigns are where we begin our relationships with donors to build the pipelines for planned giving and major giving. We are getting prepared for the Centennial celebration and building more capacity on the FMCC board.
