







High quality academic programs, outstanding instructors, and dedicated staff providing supportive students services help ensure that all students coming to MCC have the opportunity to succeed






At the heart of MCC's mission is the commitment to prepare students for successful transfer to pursue advanced degrees. Strong academic programs, dedicated instructors, and supportive counseling and advising services provide students with a firm foundation for their academic career. Instructors, counselors, and staff work together to help support the successful transfers in a variety of ways:

- MCC's Stevenson Center for Higher Education is home to three Universities; Ferris, Grand Valley, and Western, providing students with the opportunity to continue their education in Muskegon
- Articulation agreements with six universities and colleges were created, providing a clear pathway for students pursuing a Bachelor Degree
- Over 20 colleges and universities participated in our annual Transfer Fair for current students and guests
- Grand Valley State University and MCC signed a Reverse Transfer Agreement, which will work to increase the number of students with MCC credentials
- 39% successfully transferred to 4-year colleges, 13 points higher than the average rate of 26% among similar-sized community colleges in Michigan







With 45 occupational degrees and 42 certificate programs, MCC provides a wide array of opportunities for students eager to develop the skills needed to start a new career. The needs of local business are also met, with Lakeshore Business and Industrial Service Center providing custom training solutions for their employees. Community members with an interest in career development, recreation programs, or learning a new hobby are able to select from hundreds of topics through MCC's Continuing Education programs. Over the past year, MCC strengthened its position as a center of life-long learning with the following accomplishments:

- 293 students earned an occupational degree or certificate
- 81 employees at 5 local businesses participated in customized training programs
- There were 560 registrants for Continuing Education classes on everything from ACT test preparation to Zumba
- \$18,660.75 in tuition fees were waived to SAM participants (Study Opportunities for Adult and Mature Citizens)



We are proud of our ability to rapidly respond to the evolving needs of the communities and students we serve. Many of our recent innovations are the result of our participation in the Achieving the Dream initiative. As we completed the second year in the initiative, we were able to use data collected to improve the College Success Seminar course, revamp Student Orientation, and restructure basic mathematics courses—all with the singular goal of strengthening student success on campus. In addition to improvements, we are developing new opportunities related to articulations, additional areas of study, expanded extracurricular activities, and new degrees and certificates. New programs implemented over the past year include:



- 12 new Entrepreneur Degrees that will help students start their own businesses related to automotive repair, graphic design, bookkeeping, and more
- · Basic EMT certificate to train first responders
- Certificate in personal computers maintenance
- Web Game Development Certificate
- Two Associate in Applied Science Degrees related to Manufacturing and Engineering Technology

- 12 new Entrepreneurial AAS Degrees
- 3 new Certificate programs
- 2 new Engineering/Technology AAS Degrees






Many students and their families recognize that Muskegon Community College is a great place for top high school students to continue their success. In addition to outstanding academic programs, students can augment their studies with participation in Phi Theta Kappa, STEM (Science, Technology, Engineering, and Math) Club, the arts, and travel opportunities. Our Honors Credits program offers the opportunity for students to work under the guidance of an instructor on additional instructor-approved study. Last year, we also developed an undergraduate research program. Over the past year, MCC helped outstanding student continue their success through a variety of ways:

- 352 high school students participated in dual enrollment programs, allowing them to earn college credits that are also applied to high school graduation requirements
- 44 high-achieving students earned Honors Credits
- 138 students were in Phi Theta Kappa, the largest honor society in American higher education
- 66 students participated in travel and other experiential learning opportunities in Belize, Germany, and the battlefields of Gettysburg and Vicksburg
- MCC nursing program graduates scored 95.38% on the National Council Licensing Examination, far higher than the 87.9% national average




We are proud of our ability to help any student reach their goal. All students have access to free tutoring and counseling/advising services to make sure they stay on track. As an Achieving the Dream institution, Muskegon Community College is closing performance gaps for students of color and low-income students with a dedication to providing anyone with the opportunity to succeed. The College Success Center helps students develop the math, reading, and writing skills needed to succeed in college and beyond. In addition to support services, we help increase to higher education by providing classes where they are needed; online and at several locations in Ottawa and Newaygo Counties. Last year, we helped students achieve their dreams through a variety of activities:

- 26 adults participated in the free 6-week "College Boot Camp" program to help nontraditional students adjust to returning to the classroom
- Enrollment in Ottawa County classes increased over 146% and enrollment in Newaygo County classes increased by over 32%
- Special Services helped 246 students with special language or learning needs
- Financial Aid processed 8,627 FAFSA applications, and administered 3,179 Pell grants totaling more than \$9.1 million in student aid
- The Foundation for MCC worked with generous donors to establish four new scholarships
- 62 high schools students in TRiO Upward Bound were assisted with the transition to college

### Enrollment Growth in Ottawa and Newaygo County Classes






Because students who are engaged are more likely to continue, persist, and graduate from college, we provide a variety of an array of vibrant student life and other activities that engage students with a diversity of interests. There is a growing body of research that supports the notion that engaged students, in and out of the classroom, are more likely to attain their academic goals, which is a major focus area for the college. Over the past year, we accomplished the following to help students engage and succeed:

- Over 200 students participated in nearly 30 student clubs and organizations
- 219 students participated in one or more of our 13
   Jayhawk athletic teams and 8 student athletes received
   Academic All American recognition, a special honor for
   those with a 3.6 GPA and 45 or more credit hours
- The Softball team won the State and Regional title, Aaron Sherman was the National Champion in bowling, and Marty McDermott was named 2011-2012 MCCAA Athletic Director of the Year
- 2012 graduates, Tammie Anderson and Hope Buell, were nominated for the All-USA Community College Academic Team and were named to the All-Michigan Community College Academic team.
- Over 600 students participated in Arts and Humanities activities including 5 gallery exhibits, 10 concerts, 9 theater and dance productions, 3 film events, and 3 lectures—some of which were related to AhFest (Muskegon Area Arts & Humanities Festival)









Alumni Relations efforts at MCC focus on building lifelong relationships with alumni by keeping them informed, showcasing alumni success, and by providing them with opportunities to stay engaged with the College. Membership in the Alumni Association is free and automatic to those who graduated from or completed 50 credit hours at MCC, but anyone who attended MCC is welcome to attend alumni events. Over the past year, staff and volunteers engaged alumni through a variety of activities:

- The Distinguished Alumni Award dinner in honor of Anthony J. Kolenic, Class of 1973, was attended by 16 fellow alumni
- 162 Alumni provided updates on their academic, professional, and life achievements for publication in *Reflections* magazine
- 17 alumni served on the Alumni Relations Advisory Committee and helped plan the second annual ReunionFest, held in October 2012



The Foundation for Muskegon Community College (FMCC) exceeded its goal of \$105,000 last fiscal year, raising \$125,143.54 in pledge and cash donations. Many of the contributions were in support of the Reach for the Stars campaign to transform the 40-year-old Carr-Fles Planetarium into a state-of-art education and entertainment destination. The campaign concluded on March 31, 2012, and renovations were completed over the summer with the new planetarium opening to rave reviews in September 2012. In addition to processing 649 cash and pledge gifts, FMCC:


- Worked with a total of 546 individual and business donors
- Processed 428 pledge payments





Because increasing access to higher education is so central to MCC's mission, we work hard to keep tuition rates affordable. Last year's tuition was \$81.50, \$143 and \$196 for in-district, out-district and out-state respectively. With the annual cost of attendance at 28% lower than some other options, MCC remains a great educational value. As MCC continues to face the challenges of declining federal, state and local revenues in the future, we will continue to work with faculty and staff to search for ways to contain our expenses and seek new revenue streams as they become available. Over the past year, the following steps were taken to reduce expenses to keep tuition affordable:

- 4,800 payment plans were activated, allowing students up to four months to pay tuition
- An energy reduction plan saved over \$90,000 and earned an additional \$10,000 in energy rebates
- Implementation of an electronic refund and student identification card resulted in a faster and more secure method of disbursing refunds to students while reducing staff time and mailing expenses

Tuition and fees are now the primary source of revenue for the College, making up 44.4% of the total revenues, as both property taxes and state aid have decreased over the last several years. Enrollment in fiscal year 2011-12 was down slightly from the previous fiscal year to 12,688 students.

Instruction includes activities that deal directly with the teaching process. Student services includes enrollment, registration, records, counseling, financial aid, athletic programs and other activities that support services to students. Operation and maintenance of plant covers the operation, maintenance, administration, utilities, safety services and other costs necessary for the proper and safe operation of the college. Institutional administration covers institutional-wide support services including the president, community relations, financial services, human resources, and other administrative functions. Instructional support expenses includes the library/information technology center, the college success center and other instructional support functions to plan, implement and manage the instructional programs offered.

### Established

In 1926, the Muskegon Board of Education founded Muskegon Junior College as only the fifth two-year institution of higher learning in the state. In 1969, the college adopted its current name, Muskegon Community College, to better reflect its expanded role in meeting the region's needs.

### **Locations**

Designed by Alden B. Dow, Muskegon Community College's main campus is located on III acres in Muskegon, Michigan. The campus is bounded on the west by U.S. 31, on the north by Stebbins Road, on the east by Quarterline Road, and on the south by Marquette Avenue. In addition to the main campus, MCC offers instruction at sites in Grand Haven, Spring Lake, Fremont, Newaygo, Grant, and Whitehall.

### Accreditation
