The fund descriptions are intentionally general to allow for flexibility. Requirements for excellent education today couldn't have been imagined in 1926 or even 2006. Similarly, the needs of future students are beyond our imagination today.

The Five Next Century Funds are:



EMERGING NEEDS FUND

supports areas of greatest need and offers the most flexibility to face future challenges.



STUDENT SUCCESS FUND

supports student success efforts such as the Jayhawk Hub and Student Emergency Grants.



INNOVATION & EXCELLENCE FUND

supports academic program and teaching excellence.



LIFELONG LEARNING FUND

supports student and community experiential learning outside of the classroom.



LEARNING ENVIRONMENT FUND

supports upgrades and redesign of classroom and other spaces to support learning.

GIVING OPPORTUNITIES:

President's Centennial Circle

President's Centennial Circle members make a gift or pledge of at least \$5,000 to a Next Century fund by the end of 2026.

The Century Society

Century Society members make a gift or pledge of \$100,000 or more to a Next Century fund by the end of 2026.

The Next Century Legacy Society

Next Century Legacy Society members let us know that they have included Muskegon Community College in their wills, trust, or estate plan with support going to one of the Next Century funds by the end of 2026.

GIFT AGREEMENTS:

Gifts made with a single payment will not require a gift agreement. The donor should specify the Next Century fund of their choice at the time of the donation. If no specific fund is noted, the gift will go to the Emerging Needs Fund.

Pledges for the President's Centennial Circle can be paid over three (3) to five (5) years in monthly, quarterly, or yearly gifts that will fulfill the pledge in the three- to five-year period. For example, a monthly gift of \$140 would pay off \$5,000 in three years. A monthly gift of \$85 would pay it off in five years.

Pledges for the Century Society may also be paid over five years. The proposed schedule for fulfilling the \$100,000 pledge would be specified in a gift agreement.

Next Century Legacy Society members will provide written documentation of their intention, including, at least, the fund which they intend to have their gift support and how they wish their names to be listed.

RECOGNITION:

Members' names will be included on a donation wall recognizing those who contributed to Next Century funds during Muskegon Community College's Centennial Celebration. This wall will include all members of these groups who do not opt out. (*Donors wishing to remain anonymous may opt out or choose to be listed as "anonymous".*)
