- Report on 2024-2025 Audited Financial Statements – *Paul Gilbert & Jennifer Wheeler from Brickley DeLong*

Paul Gilbert and Jennifer Wheeler from Brickley DeLong presented the 2024-2025 Audited Financial Statements, the Single Audit of Federal Financial Assistance Programs, and a letter to the Board. The College received an unmodified opinion, the most favorable opinion that can be received, which indicates that the financial statements are presented fairly in all material respects according to generally accepted auditing standards.

- Artificial Intelligence (AI) at MCC - *Dr. Tucker Brown, Provost & Chief Student Services Officer*

Dr. Brown highlighted some of the neat AI-related initiatives that are going on at MCC.

MCC has a statement that “we are committed to integrity and recognize generative AI both as a useful tool and as a potential threat to scholarly values...” The College is continuing to work on our adoption of Artificial Intelligence. MCC faculty are participating in a pilot of SchoolAI. Dr. Meg Lockard recently gave a presentation on AI at MCC on Tap at Pigeon Hill.

The IT department is developing training and support. IT has been using AI for Fraud Detection, looking at fake student accounts and financial aid scammers.

Our Tech Council is looking at a draft to ensure tools are aligned with our standards.

Artificial Intelligence in the workplace was recently used at the College’s staff meeting on Friday. Stacey DeBrot used AI in her Goal #3 “We Shine Together” presentation which was shared with the Board.

We are offering a new 3 credit course this winter, CIS-297AI Introduction to AI. The course is ideal for anyone looking to gain confidence and practical skills in the rapidly evolving field of AI.

TOLTech tables are a new and emerging technology that can be used virtually for use in healthcare and biology related courses.

V. Administrative Reports

A. President's Report – *President John Selmon*

President Selmon shared Federal, State and MCCA updates. The Federal shutdown has ended temporarily. We are continuing to look at Workforce Pell training. The State of Michigan has 9 stranded Bills tied up in the courts, including the Public Employer Health Insurance Contribution Act or PA 152 which will impact community colleges.

The recommendations for the MCCA 2026 Legislative Priorities will go to the full MCCA Board of Directors in January 2026 for approval.

ACCT Governance Leadership Institute will be December 4th – 5th in Lansing. Trustee Scott and President Selmon are planning to attend.

Thank you to Trustee Scott for presenting at the ACCT Conference in New Orleans. Trustee Scott did an excellent job articulating her experience as an adult-learner at MCC.

Supplemental Nutritional Assistance Program (SNAP) benefits are part of the federal shutdown. We are working with several community organizations to help support MCC students and the larger community. The Jayhawk Hub food pantry has experienced an uptick in requests for support since the shutdown.

MCC administrators are engaged in conversations related to best practices and ways to strengthen partnership initiatives with Mott College, Kellogg Community College and Ferris State University. We have been talking to Mott College about strategic planning. The Cabinet will be visiting Kellogg Community College in December. Ferris State University leadership visited us to talk about strengthening our partnership and possibilities that lie ahead for the two institutions.

President Selmon thanked Trustee Frye for doing the Reflection at the MCC Veterans Salute.

Tatum Dykstra was named All American in U.S. Track and Field and Cross-Country. Nick Marcinkowski was named MCCAACoach of the Year. MCC earned several All-MCCAAConference players awards.

The NJCAA Men's golf compliance issue was discussed, and solutions were shared. The college was fined \$1000 and put on probation for a semester for not reporting the MCC's fall golf team's intention of participating in the fall as well as the spring seasons.

The EXPO Open House was on Saturday, November 8, and had 380 people in attendance. It was one of the biggest EXPOs events for the college in recent years.

MCC conducted a lockdown drill on Thursday, November 13, President Selmon thanked the local law enforcement agencies, Muskegon, Norton Shores, and Muskegon Heights police departments for their support.

Winter 2026 enrollment is at 13.3% headcount and 16.5% contact hours.

President Selmon and Dr. Brown shared information related to the two Muskegon Public Schools Innovation Academies, Health & Human Services, and Industry, Technology & Design and MCC's role in this initiative. President Selmon is on the Strategic Steering Committee for MPS which meets three times a year. Dr. Brown, Dr. Briggs, Dan Rinsema-Sybenga and Lisa Gatti-Brown are involved in the programs. Dr. Brown is working on a competency piece with employers and representatives from Muskegon Public Schools. Our courses will fit into the academies, and soft skills for students are a component.

The Board of Trustees (Strengths, Weaknesses, Opportunities and Threats (SWOT) analysis summary was shared. Next, the Board SWOT will be analyzed by the ATD coaches and shared with the college-wide strategic team for review and adoption where possible. The Board will see the ATD SWOT analysis summary during the December meeting.
