**RESOLUTION OF THE BOARD OF TRUSTEES OF  
MUSKEGON COMMUNITY COLLEGE DISTRICT**

A majority of the members elect of the Board of Trustees approve the following resolution at a public meeting of the Board of Trustees held in compliance with Act No. 267 of the Public Acts of 1976:

**OPERATING MILLAGE RESTORATION**

WHEREAS, the Muskegon Community College District (the “District”) is a community college district organized and operating under the Community College Act of 1966 (the “Act”) (MCL 389.1 *et seq.*), as amended; and

WHEREAS, in May 1993 the electors of Muskegon County approved the renewal of the District’s charter tax rate of 2.4 mills to be used for the purposes authorized by the Act; and

WHEREAS, on April 29, 2026, the Board of Trustees of the District approved a resolution authorizing a ballot proposal to be submitted to the Muskegon County Clerk seeking a new additional millage of 0.2705 mills; and

WHEREAS, after the Board of Trustees of the District approved the ballot proposal, the county sent to the District revised projected mill calculations; and

WHEREAS, the county now projects that the operation of the Headlee Amendment has reduced the District’s millage to 2.1020 mills; and

WHEREAS, the amount of the reduced funding under the Headlee Amendment is needed by the District to support learning environments, safety improvements, infrastructure upgrades, long-term academic support, and other purposes authorized by law; and

WHEREAS, the Board of Trustees of the District has prepared a revised ballot proposal seeking a new additional millage of 0.2980 mills to reestablish the total levy of 2.4 mills previously approved by the electors in May of 1993;

NOW, THEREFORE, BE IT RESOLVED, that the ballot proposal attached as Attachment 1 be submitted to the Muskegon County Clerk to appear on the ballot for the 2026 August Primary Election according to applicable law.

FURTHER RESOLVED, that the ballot proposal attached as Attachment 1 supersedes the ballot proposal approved by the Board of Trustees of the District on April 29, 2026.

## **Attachment 1**

### **Muskegon Community College District Operating Millage Restoration**

This ballot proposal authorizes a new additional millage of 0.2980 mills for Muskegon Community College to restore the total amount of mills that Muskegon Community College receives for its operating millage to the original 2.4 mills approved by voters under the applicable law in May of 1993. The Headlee Amendment has reduced this operating millage to the current 2.1020 mills.

Shall the limitation upon the total amount of taxes that may be levied against all taxable property within Muskegon County be increased by 0.2980 mills (\$0.2980 per \$1,000.00 of taxable value) for 30 years, beginning in 2026 and continuing through 2055 inclusive, to support learning environments, safety improvements, infrastructure upgrades, and long-term academic support for Muskegon Community College and other purposes authorized by law? Revenue from the proposal will be disbursed to the Muskegon Community College District and, to the extent required by law, a portion of the revenues will be captured by or disbursed to the brownfield redevelopment authorities of the City of Montague, City of Muskegon, City of Muskegon Heights, City of Norton Shores, City of Roosevelt Park, City of Whitehall, Fruitport Charter Township, and Whitehall Township. It is estimated that \$2,100,000.00 will be collected in the first year that the new additional millage is authorized and levied.
